

FAMILY SERVICE TO SCHOOL AGREEMENT

Policy Statement

In an effort to provide services and educational enrichment programs to the children of St. John School, a **service-to-school agreement is required of all registered families.**

Please Note: outstanding hours or monetary contribution must be reconciled **before final** report cards and/or issuance of any school transcripts are issued.

- **Each family must have a Service to School Agreement form on file with the PTO by Friday, September 21, 2007.**
- **Each family must also have the FSHP Acknowledgement form on file with the PTO. The Acknowledgement form is located in the Parent Handbook and due back to school by September 21, 2007**

OPTION ONE

If a registered family will be unable to perform the 12 or 6 hours(single parents) creditable service during the school year, a contribution of \$300.00 (\$150.00 if a single parent) is payable to St. John School.

For Pre-K families only, who will be unable to perform 12 or 6(single) hours of creditable service during the school year, a contribution of \$300 (\$150 if a single parent) is payable to St. John School.

Installment payments are **due on September 21, 2007 and January 18, 2008.** Or a single payment for the full amount may be made by **September 21, 2007.**
